#### **PRODUCT DESCRIPTION**

A highly effective, perfume-free antibacterial lotion hand wash.

#### WHERE TO USE

#### HOW TO USE

For general hand washing – apply 3 doses (3ml) to WET hands and rub in well across all parts of hands for 60 seconds. Rinse hands thoroughly with clean running water and dry well.
